He came under fire from various members and Mardi, who was herself posting as 'Tuesday', jumped to his defence. She signed off, 'Tuesday, Morse's girlfriend.' [2]

Mardi has recently created her own blog, unlike her boyfriend, who seems to be infatuated with me, she focuses on issues pertaining to a whole range of SSRi's. Moreover, she has recently drafted an article pertaining to her discussions with the MHRA, part of which reads, "...whereby the contemptuous, disrespectful activities of Mr Bob Fiddaman of the fiddaman.blogspot continues - along with his stalking and harassment, in an attempt to undermine, intimidate and discredit me - for some warped perverse reason known only to himself." Mardi is well aware that her boyfriend, be it current or former boyfriend, has created a blog aptly named 'Seroxat Sufferers Stand Up and Be Counted', exactly the same name as this blog. She is also well aware that he posts as 'Bob Fiddaman' and furthermore well aware of the content of his blog where he not only tries to discredit me but continues to try and discredit prominent figures such as Dr. David Healy. He also seems fixated on the solicitors handling the Seroxat Group Action plus a whole host of other people who have spoken out against Seroxat.

I am unsure of Mardi Bennett's current state of health but to accuse me of 'stalking and harassment' seems rather peculiar, particularly when her boyfriend seems to get his rocks off by posting about myself and other Seroxat campaigners on a daily basis. His blog, which was created in or around August 2008, is a classic case of delusional rants and supposition. I have contacted Blogger, the West Midlands Police and the Police Service of Northern Ireland regarding Jeremy's antics, but it seems it is a civil matter and not a criminal one. A claim of libel would cost in the region of £30,000.

I suggested to the West Midlands Police if I could counteract his claims by creating my own blog. They thought it was a good idea. So, I created the Strangford Bryce blog.[6]

Mardi, and/or her boyfriend, it appears, have recently requested documents from the MHRA that pertain to a recent meeting I had with Simon Gregor. Quite why they are wasting the MHRA's time is unknown. [7,8]

The MHRA have, in the past, used the word, 'Vexatious' to various campaigners. I think, in the case of Mardi Bennett and Jeremy Bryce, the word fits perfectly.

I continue to have discussions with the MHRA and we continue to build bridges, something Messrs Bonnie and Clyde should be concentrating on rather than their deluded fantasies that there is some sort of huge push to get Seroxat noticed and no other SSRi/SNRi.

think you have problems Fiddaman - neonatal outcomes for Christiane Schultz who was taking Effexor for several years' and 'Matthew Schultz - murdered by Wyeth, the Mark Harvey's & the greedy Fiddaman's, who would have you believe Seroxat is the worst SSRI'

And Mardi Bennett thinks I'm harassing and stalking her?
